#### **School Governance Overview**

- As mandated by School Law your Governing Body resolved to appoint Rob Vine and I to the
  positions of Vice Chairperson & Chairperson respectively for another year, both Rob and I
  recognise the responsibility given over to us by our fellow Governors and we will continue to
  lead our highly committed and motivated Governing Body in the pursuit of giving your children
  the best possible start in life and an environment in which to reach their potential and "be the
  best they can be".
- As always we have been working hard to secure additional Governors onto the committee to add breadth and additional support to the Head Teacher to continue our drive for improvement.
   We are very pleased that Mrs Zoe France has joined us in the position of Clerk to Governors, a role that is at times very demanding but without which a Governing Body struggles to be truly effective.
- In line with our "Instrument of Governance" we currently have vacancies for a second Foundation Governor and a third Community Governor and we continue to look at opportunities to fill those vacancies to strengthen the leadership of the school.
- As I alluded to in July we would also be very keen to appoint a second Associate Member to our GB, someone with key subject matter skills centred on Standards and Curriculum in Primary Schools. - Your Governing Body has worked tirelessly over the course of 2012 to really embed the foundations of School Governance by having a full and detailed review of all policies within school. These will be continually reviewed and amended where necessary and will form the basis of our Monitoring and Evaluation visits going forward to ensure adherence and effectiveness of the Policies. Just to put this into perspective the school currently has over 40 Policies which we have to ensure are fit for purpose and bound us to the requirements of the Law.
- Your Governing Body is also working hard to ensure there is a culture of continuous improvement across all aspects of school life but heavily weighted towards Teaching & Learning and Leadership and Management as these are the areas that can offer the most value to your child making the greatest progress.



## **Highlights**

- At the end of the Financial Year (March 2012) the Staffing & Finance Sub-Committee were very
  pleased to report to the FGB that the school had moved back into the black for the first time in
  nearly 5 years. This is an extremely significant milestone and one that had been impacting the
  rate of improvement across the whole of the school. We are now able to utilise our full budget
  allocation in our quest to drive the pace of improvement throughout the school in key areas such
  as teaching & learning.
- As a Governing Body we are always analysing and scrutinising data, in the main by our Curriculum Committee, and this data clearly shows, in a very high percentage, 87%, of cases, your children continue to make at least good progress in their outcomes (Attainment) and the trend continues to be upwards across the whole school as we strive for excellence for every child. In cases where good progress in not currently being achieved, highlighted children or group intervention is immediately scoped to bring those children or groups back making good progress.
- The new Deputy Head position, as resolved by the Full Governing Body (FGB) last year, is also providing more room for leadership growth and a more strategic window of opportunity within the Senior Leadership Team for improvement areas to be highlighted and exploited in line with the Schools Development Plan (SDP).
- The Schools financial position continues to be broadly in line with the budgets set at the start of the School's financial year, which is 1<sup>st</sup> April, and our Staffing and Finance Committee (S&FC) meet at least five times per academic year to review expenditure before reporting back into the FGB with their assessment.
- I hope as Parents / Carers you have noticed some of the improvements that have been made both in and around the school. The Head teacher and Staff have worked hard to recognise where improvements can be made to maximise the Personal, Social and Emotional Development (PSED) in line with the targets set within the SDP and have used the School's Devolved Capital money to turn their ideas into reality, I'm sure your children have discussed with you some of their feelings towards the improvements. It is very much a part of the Schools overall vision to develop our children outside the classroom as well as in it.
- As our long serving PTFA Chair, Helen Maughan, leaves behind a legacy of leading the PTFA
  in providing additional funds and some great memories for which we are very thankful, there is a
  new look to your PTFA this year as we welcome members new and old who will I'm sure
  continue to give us their valuable time to organise some great events. Please support wherever
  possible as all the money raised goes directly back into school and therefore back to the
  children.

## **Going Forward**

• As reported recently in the national press, more scrutiny is being placed on schools to provide tangible evidence that Pupil Premium money (which is additional to main school funding, and is seen as the best way to address the current national underlying inequalities between children eligible for free school meals (FSM) and those whom are not by ensuring that funding to tackle any inequalities reaches the pupils who need it most) is being used to raise ATTAINMENT and not as Ofsted chief Sir Michael Wilshaw described "Tarmacking Playgrounds". Therefore the S&FC will work on behalf of the FGB with the Curriculum Committee to ensure that a joined up approach at committee level will lead to evidence being generated that proves we are giving everyone the best available opportunity to progress.



- Governor's focus for 2012-13 is to improve our visibility in School with increased Monitoring & Evaluation visits, focusing on Safeguarding; Policy adherence and classroom / subject support and challenge. A number of governors have already visited the school this term and have been waqrmly received and suitable impressed with the continuing high standards. We record our visits and any actions or outcomes for future follow up. This is seen as an effective method of School Governance and strengthens the bond between Governors; staff & Children alike.
- We have a new Website!!! (www.ancasterprimary.org.uk) Significant effort has gone in to raising the profile of our great School and our website is one of the first ports of call for any new parents, existing Parents / Carers, OFSTED inspectors and many others. We hope you will see it grow over the next few weeks into an informative and reflective area for you to see firsthand both what has been done and what is to come. Please feedback any comments, good or bad, to our deputy head that will be more than happy to receive feedback.
- Subject focus for Term 2 is all around Religious Education and Term 3 is around Science (including outdoor learning). For more information please see the Class Teacher or Head teacher.
- The Curriculum and Enrichment topics for term 2 will be around Anti-Bullying, "Time Detectives" and "It's a Miracle", again for more information please see the Class Teacher or Head teacher.

## **Safeguarding**

I make no apologies for leaving this section relatively un-touched; it is by far our biggest priority. You entrust your children with us every day on the premise that they are to be safe as well as educated, I know you, like us, will do your utmost to work with us to protect the children and staff of Ancaster CfE School.

In the words of Her Majesty's Chief Inspector:

'Safeguarding...is an issue addressed not only with increasing sureness by those responsible for keeping children and learners safe, but one felt keenly by those most vulnerable to harm and neglect.'

As a school we are responsible for every aspect of your child's safety and wellbeing, we feel we are doing this well under our control within the school grounds; however we could all do more to ensure this extends out into the community. In particular we are all concerned for the safety and wellbeing of everyone outside of the school gates, specifically at drop off and pick up times. There is recognition that the amount of parking, egress and ingress to the school is limited due in part to our rural location. That said it would help protect everyone if:

- We DO NOT use the area outside our school gates as a turning circle under any circumstances,
- We please respect the designated no parking zones as defined by the road markings?
- Avoid parking on the corner of Mercia Drive & Ermine Street
- Give the Lollipop Person specific room too effectively and safely get pedestrians across the busy main road and give them line of sight for oncoming traffic by avoiding parking the school side of the Post Office.

Just like you we are concerned that after all the hard work put in by the community to ensure the highways department continued to provide us with a crossing service they have been unable to fill the



position. We like you will continue to help where we can to get someone in place, ultimately though it is the responsibility of our local council to provide this service.

# **Academies**

No further discussions have taken place with respect to Academies. Should they we will inform you immediately. In OFSTED speak our priority is to embed Good to Outstanding practices within the school, show we can sustain the levels at which the School is currently operating and build on the foundations we are beginning strengthen.
