September sees the launch of Universal Free School Meals, in which every child in Foundation Stage, Year 1 and Year 2 is entitled to a free hot school meal on a daily basis. As this will significantly increase the numbers of meals we provide each day, we decided to explore alternative caterers and negotiate prices to ensure we are sourcing the best possible meals at the most reasonable prices for parents who will pay for meals.

**We are very excited to announce that we have agreed to work with a provider called, 'Good Looking Cookin'.** Their menu is excellent with different options and the food quality and portion sizes are superb. They will also charge £2.30 per meal and offer the same online booking system as Farm Kitchen.

We want as many children to enjoy a hot meal in school each day, and want you to know where the food is coming from and the people cooking it, therefore, **we have arranged a taster session on Monday 23<sup>rd</sup> June at 3.30pm in the school hall.** All parents and children are welcome and this will be hosted by the owners of the business-we look forward to seeing you there!

## Changes to provision for SEN

This September the Department for Education (DfE) are making changes to the law for children and young people with special educational needs and disabilities. The new law will result in changes to the way you and your child will receive support from your local council, health and social care services and your child's nursery, school or college.

There is now a greater focus on personal goals, increased family involvement and improved rights and protections for young people in further education and training. The DfE are assuring everyone that this is not about cutting services but about creating a better system that puts parents and their child first. It is expected that the changes will take three and a half years to implement. Until the changes are complete the current protections you and your child have will continue and, in many cases, be enhanced further.

Statements of Special Educational Needs and Learning Difficulty Assessments are being replaced with a single education, health and care (EHC) plan for children and young people with complex needs. The EHC plan will place much more emphasis on personal goals and will describe the support your child will receive while they are in education or training. They're also introducing personal budgets to accompany this plan to give you more control over the support you and your child receive. The amount you would be given, and how it can be spent, is something that you would agree with your council. For children with less complex needs who still require help, they are introducing a new system called Special Educational Needs (SEN) support, which replaces School Action and School Action Plus. The process will be similar but it will be less about counting the hours or resources given to your child at school and more about what your child has achieved as a result.

If your child already has a statement or Learning Difficulty Assessment they will be transferred to the new system within the next three and a half years. The transfer is likely to happen around transition points in your child's education such as when they move from Primary to Secondary school. The legislation relating to Statements and Learning Difficulty Assessments will be withdrawn when everyone has completed the transition to the new system.

If your child currently receives help at school through School Action or School Action Plus, the transfer to SEN support will take place between September 2014 and spring 2015. It is likely to be during one of your child's termly reviews. At school we are preparing for this transition so that it is as smooth as possible. In the meantime, please be assured that our philosophy will not change. All children will be treated fairly and equally and those with a learning difficulty will be supported in their learning through good planning, teaching and intervention.

## Maths Quiz-Y6



**On Friday 13<sup>th</sup> June, Mr Eden took 4 Year 6 pupils to St. George's Academy in Sleaford to take part in a maths quiz against 13 other local Primary schools.**

The questions were purposely designed to challenge the pupils taking part, and whilst we didn't win the competition, we came 5<sup>th</sup> out of 14 and could not be prouder of Sam Holmes, Heather Butters, Libby Stafford and Ben Elmes-Well done! We were especially proud that our pupils chose to congratulate the winning team without prompting, showing excellent sportsmanship!
